What does it mean for CARS to become the System of Record?

On March 21, 2015, the Central Accounting Reporting System (CARS) will become the central accounting System of Record (SoR) for the Department of the Treasury, Bureau of the Fiscal Service. As the newly designated SoR, CARS will replace the legacy system, STAR, and will be the official source for the posting of financial transactions which impact all Federal Program Agency's (FPAs) Fund Balance with Treasury (FBWT).

How does the date announcement affect my agency?

To accomplish this transition, CARS will be taken offline during this conversion. This may have a direct impact on your agency's ability to perform business functions within CARS. Specifically, CARS will be unavailable for users beginning Friday, March 20, 2015, at 2:00 PM EST until Wednesday, March 25, 2015, at 8:00 AM EST. We ask that users do not process any transactions or log into CARS during this time.

From now until March 25th, 2015 we ask that agencies, who are full GWA reporters, not enter reclassification transactions for the March 2015 accounting period. Due to the conversion, any reclassified transactions that are entered from March 1st, 2015 through March 20th, 2015 for the March 2015 accounting period may require additional agency approval after the deployment is completed.

How does this change benefit my agency?

There are several benefits to your agency as a result of CARS becoming the new SoR:

1. Account Statement improvements.
 - a. The Provisional view will no longer be available in the Account Statement. The detailed transaction data that was previously available in the Provisional view will now be available in the Accounting and Published views.
 - b. In the existing Provisional view, detailed transaction data is only available for the current calendar month. After the change is made, detailed transaction data will be retained beyond month-end and will remain available for query in subsequent months.
 - c. The detailed transaction data will now be available for view and download on the last day of the month and during the open window.
 - d. For full TAS/BETC reporters, reclassification at the detailed transaction level will be available during the open reporting window for the previous month. (For example, on May 1, 2015 detailed transaction level reclassification can be accomplished for April 2015 transactions viewed in the Account Statement.)
2. The new Statement of Difference (SOD) and Check Issue Audit (CIA) modules replace the GOALS II/IAS Statement of Difference system and the reports that were emailed directly to agencies.
 - a. SOD is a new module in the CARS that can be used by all users. SOD provides enhanced functionality by allowing FPAs to view their Agency Location Codes (ALCs) to identify balance differences between agency and source system reporting.

- b. CIA is a new module in the CARS that can be used by Treasury and Non-Treasury Disbursing Offices. CIA provides enhanced functionality by allowing FPAs to view their ALCs to identify out of balance conditions between agency and source system reporting.
3. The Agency Standard Reports (ASR) module will now be available for use to pull reports at any time. These reports are updated daily. This module replaces the reports that were previously emailed to the various FPAs.

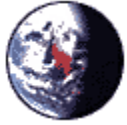
