# Survey Results

---

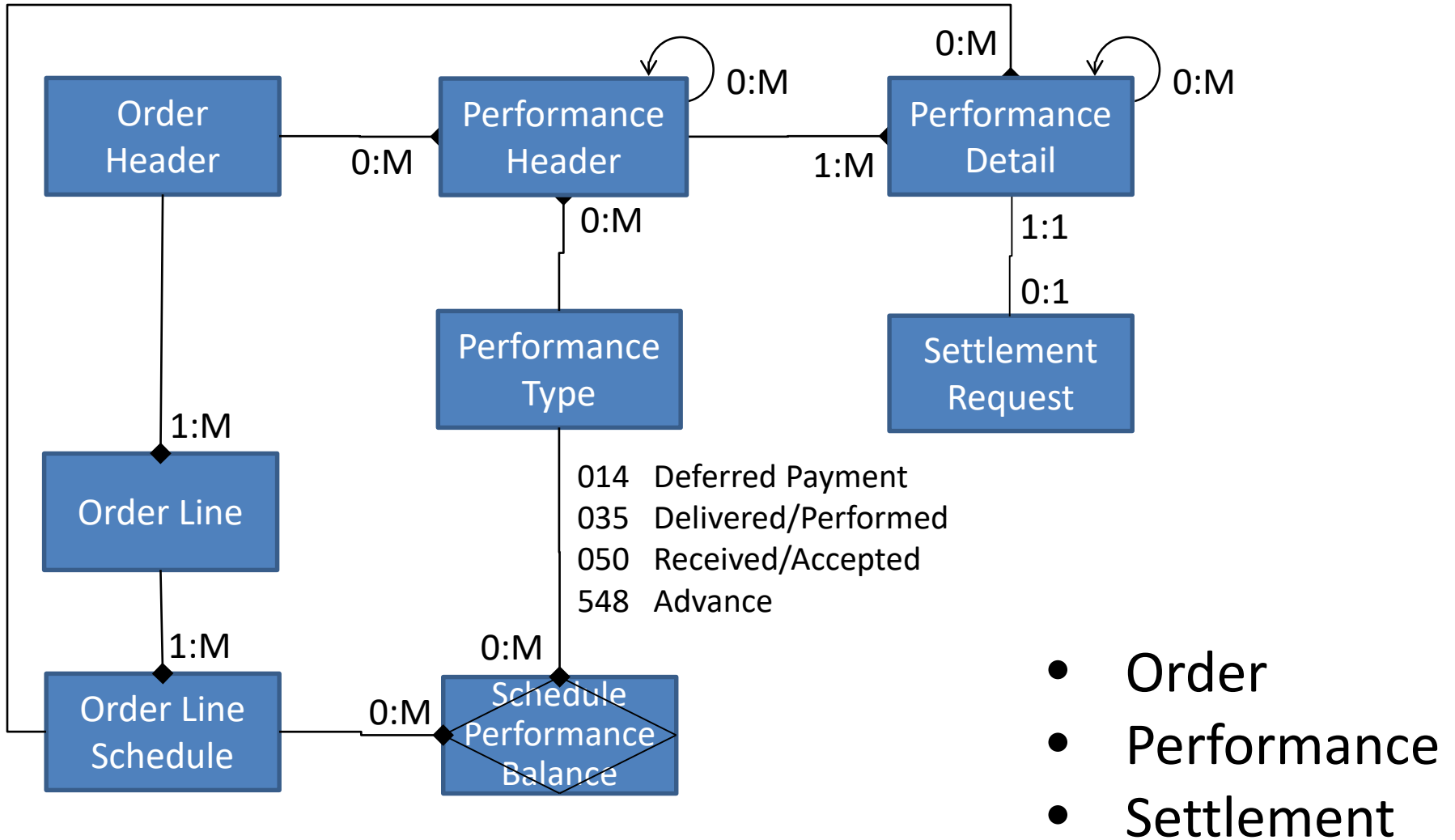
- Program Guide was well received
  - Agencies would like more time to review and possibly be represented during another ITWG meeting
- Suggestion that Performance always be reported by Seller
  - Not all agencies agree with Seller-only performance
  - Agencies can negotiate FOB Point = Source with their partners, which removes Buyer side reporting requirements (and controls)
- Recurring advances are needed

  - Performance specs will be finalized in February not January
    - Reviews ongoing
    - Some of the new rules are on later slides
  - Orders release (2.2) March 4, 2019
  - Release (2.3) is on track to release in August 2019

# Performance Rules

---

- Performance must reference open Order and active Lines/Schedules
- Performance Date must fall within the performance period of the Order
- Performance submitted by requesting agency must reference Delivered/Performed submitted by servicing agency
- The requesting agency cannot respond to a negative (aka, adjustment) Delivered/Performed submitted by servicing agency
- Net amount (by Type) reported against a Schedule cannot exceed Order Schedule Amount, thus preventing balances from falling below 0
- Net amount (by Type) reported against a Schedule may not fall below zero, thus preventing balances from rising above Order Schedule Amt.
- When Advance Payment Indicator is True, Deferred Payment not allowed
- When Advance Payment Indicator is True, the net amount of Delivered/Performed may not exceed the net amount of Advance
- When Advance Payment Indicator is False, performance type Advance is not allowed

# Constructive Receipt Days

---

- Under the following conditions the G-Invoicing system will generate a *Constructive Receipt* to guarantee timely reimbursement for goods **delivered** or services **performed** by the Servicing Agency:
  - FOB Point is Destination (or Other) for the Order
  - The requesting agency has not submitted Received/Accepted performance
  - The number of Constructive Receipt Days for the Order have elapsed since the Performance Date and the Transaction Date

*Note: The constructive receipt will be generated the morning after the Constructive Receipt Days period elapses*

# Performance – FOB Source

- Delivered/Performed is required in every case (by Seller)
- Advance followed by Delivered/Performed for Liquidation
- Deferred Payment is followed by Delivered/Performed (to Collect on Work in Progress)

# Performance – FOB Destination

- Delivered/Performed by Seller is followed by Received/Accepted by Buyer
  - Constructive Receipt enforced by G-Invoicing after ‘n’ days

# New Rules for Orders

---

- Modification of Orders will be limited to protect reported Performance
  - Order Line cannot be cancelled if there is any performance against it
  - Order Schedule cannot be cancelled if there is any performance against it
  - Order Schedule Quantity cannot be lowered such that the remaining balance for any Performance Type drops below zero
- Orders cannot be closed when out of balance
  - Advance amount must equal the amount Delivered/Performed
  - Deferred Payment amount must equal the amount Delivered/Performed
  - Amount Delivered/Performed must equal the amount Received/Accepted, if FOB Point is 'Destination'
  - Amount Delivered/Performed must equal the amount Received/Accepted, if the amount Received/Accepted is provided

*Note: Received/Accepted is not required when FOB Point is 'Source'*

# Administrative Changes to Orders

---

- Allow limited changes to open Orders
- Bypass official modification and approval steps
- Can be initiated by either trading partner
- Partner can only change their own Administrative data

# What's Next?

---

- Remittance Advice

- Settlement reporting will be provided once G-Invoicing begins initiating settlement requests
- G-Invoicing will mark Performance as “paid” and store keys to IPAC (e.g., Transaction ID, DO Symbol, Doc Ref Num)
- Not all data included in IPAC’s “CSV/TSV file” will be saved in G-Invoicing
  - For example: no Submitter ALC, no Contact Name/eMail/Phone, no UOI, no SGL
- Remittance data will be made available in two forms
  - Pull API will provide XML
  - Data extracts will produce CSV
- Remittance FIDS will be drafted during the first half of calendar 2019
  - ITWG will be involved in establishing requirements
