**Notes:**

- 1) The FY 2015 reporting window schedule is based on statutory language, which OMB anticipates will be repeated from FY 2014 and beyond.
- 2) The Bureau of the Fiscal Service will require all TAS to be reported in each reporting window.
- 3) Certified agency bulk files submitted during the reporting window will be used to derive the quarterly intragovernmental reporting data. NOTE: Only certified data is used for Intragovernmental Reporting.
- 4) \* Agencies must certify Expenditure TAS NLT October 19, 2015, 5 PM EST. OMB will import submissions as of this date into the PY column of the Budget P&F Schedule. Agencies may revise these data later in the window but must coordinate changes with their budget offices to ensure agreement between GTAS submissions and the Budget.
- 5) The times included on the reporting window schedule represent when the bulk file flag will be turned on/off. The system will always be available for reports and analytics.
- 6) The Intragovernmental Period Extensions will be gradually shortened beginning in FY 2016; eventually phasing out by FY 2019.
- 7) Fiscal Service will extract certified TAS balances October 26, 2015 after 5 p.m. EST for use in Quarter 4 Intragovernmental Material Difference/Scorecard Reporting.
